

PRIVACY POLICY

REALGATE INC. (hereinafter referred to as "the company") recognizes the importance of the personal information of the customers who use our website www.thesite.jp/ (hereinafter referred to as "the website") and handles such information with the greatest care. This "privacy policy" stipulates how we collect your personal information, and which of your personal information we collect so that you feel secure when visiting the website. With regard to the treatment of personal information, our company establishes and complies with the company regulations for personal information control which meets the personal information protection law and the related laws, regulations, and norms. When visiting the website, please understand "the policy" well and provide us with your personal information only if you consent to "the policy".

■Collection, use, and distribution of personal information

In order to ensure the smooth operation of our business (such as requests for information material, registration, survey questions, mail magazine services, or other), our company acquires and retains certain personal information about our clients, including names, addresses, telephone numbers, e-mail addresses and occupations ("Personal Information"). We recognize that the proper safekeeping of this Personal Information is an important obligation, and have therefore established the following policies for our handling of all Personal Information.

Using and providing personal information our company manages personal information in a strict manner, and except when required by law, this information will only be used or provided according to the purpose approved by the customer.

■Handlings of the Personal Information

Our company will appoint a Personal Information Manager to ensure the proper and strict safekeeping of the Personal Information received from our clients, and will strive to preserve the accuracy of all Personal Information. Furthermore, we will implement the necessary and appropriate level of safety measures to prevent the risk of any Personal Information being disclosed outside of the company and of any improper external access to the Personal Information, based on our Regulations for the Custody of Personal Information and Rules for Dealing with Personal Information. If company engage any third party to deal with all or any part of our Personal Information to the extent required to achieve the purpose of use of that information, before we provide such Personal Information to the third party, we will confirm that the third party has adequate measures for the safekeeping of that information, and will enter into a contract with that third party for the custody of that Personal Information, as well as put in place any other appropriate measures.

■Access Logs

This site records information concerning the persons who visit in an access log which includes the IP address of the user. This site's access log is utilized for purpose of statistical analysis regarding access trends and numbers, and the diagnosis of the Company's server problems, and shall not be used for other purposes.

■Limitation of provision to a third party

The Company shall not handle personal information beyond the necessity to fulfill the purpose of use without consent from the person in question.

However, the following cases are exceptional.

*Cases in which the provision of personal information is based on laws

*Cases in which the provision of personal information is necessary for the protection of the life, body, or property of an individual and in which it is difficult to obtain the consent of the person

*Cases in which the provision of personal information is specially necessary for improving public hygiene or promoting the sound growth of children and in which it is difficult to obtain the consent of the person

*Cases in which the provision of personal information is necessary for cooperating with a state institution, a local public body, or an individual or entity entrusted by one in executing the operations prescribed by laws and in which obtaining the consent of the person might impede the execution of the operations concerned

■Information Management; Security

To ensure the accuracy and safety of personal information, Company takes reasonable measures against such risks as unauthorized access, unauthorized disclosure, and loss of or damage to personal information. The Company maintains reasonable safeguards to protect Personal Information against loss, unauthorized use, disclosure or destruction and when transferring information for processing. We restricts authorized access to your personal information to those persons who have a legitimate purpose to know that information to provide products or services to you and those persons you have authorized to have access to such information. We also require that third parties providing services on our behalf protect Personal Information and not use it for purposes other than providing assistance to the Company. In the event that any individual in respect of whom we hold Personal Information wishes that information to be amended, supplemented or deleted, we will, without delay, after first confirming the identity of the individual making such request, effect the relevant change so that the relevant Personal Information is in accordance with fact.
